Thank you for your application for a Visitor Visa - General. We received your application on 27-February-2024.

Our assessment of your application

We have completed an assessment of your application and have identified the following issues which may have a negative impact on the outcome of your application.

Ties in home country

Immigration instruction V2.1(a)(ii) states that to be granted a visitor visa an applicant must meet the requirements for bona fide applicants. Instruction E5.1 states that a bona fide applicant is one who genuinely intends a temporary stay for a lawful purpose, and is not likely to remain unlawfully or breach their visa conditions. Instruction E5.10 lists what must be taken into account to determine this, and includes the personal circumstances of the applicant, including the nature of any personal, financial, employment or other commitments in the home country and New Zealand (instruction E5.10(a)(iv)).

Evidence of your work and living arrangements in your home country helps us decide if you are likely to return to your home country at the end of your visit. We acknowledge you have provided a leave application letter however it states it is for 30 days. You have not provided any other evidence to show how you are able to support yourself in your home country or any other evidence of your personal, financial, employment or other commitments to demonstrate that you are a bona fide applicant. Taking this into account, along with your intentions and other relevant information, you may not meet the requirements of instruction V2.1(a)(ii).

Travel history

Immigration instruction V2.1(a)(ii) states that to be granted a visitor visa an applicant must meet the requirements for bona fide applicants. Instruction E5.1 states that a bona fide applicant is one who genuinely intends a temporary stay for a lawful purpose, and is not likely to remain unlawfully or breach their visa conditions.

It appears that you have not provided sufficient evidence of your previous travel experience or your planned travel to New Zealand; therefore, you may not be coming to New Zealand for a genuine reason, and may not meet instruction V2.1(a)(ii).

Genuine lawful purpose

Immigration instruction V2.1(a)(ii) states that to be granted a visitor visa an applicant must meet the requirements for bona fide applicants. One of those requirements is to genuinely intend a temporary stay for a lawful purpose. 'Lawful purpose' for visitors is defined in instruction V2.1.1, and includes:

- holidaying
- sightseeing
- family and social visits
- amateur sport
- business consultation
- medical treatment, or
- guest of government visits.

It does not include work or study for more than three months.

You have declared that the purpose of travelling to New Zealand is to visit family. We acknowledge that you have provided a supporting letter from your sponsor, and photographs however, this is not sufficient information to show your familial relationship to support your genuine intent to travel to New Zealand. We are not satisfied that the information provided sufficiently demonstrates that you have genuine intent to visit New Zealand for a holiday or vacation. Therefore, it appears that you have not provided sufficient evidence that your reason for travelling to New Zealand meets this definition, so you may not meet instruction V2.1(a)(ii).

You must tell us about any changes to your circumstances that may affect your application for a visa, including but not limited to changes to the following:

- the personal or family circumstances of any person included in the application
- your address or contact details (including postal address, email address, and telephone number)

If you do not tell us about changes to your circumstances, we may decline to grant you a visa or you may become liable for deportation. While you are in New Zealand, you must hold a valid visa at all times.
